

## Fuel Economy Settlement for Gasoline-Powered Audi, Bentley, Porsche and Volkswagen Vehicles

Under the settlement, cash payments range from \$518.40 to \$2,332.80 for original and sole owners of the Class Vehicles, to compensate them for driving vehicles for which the actual, on-road fuel economy is up to 1 MPG less than was originally represented. If you leased your Class Vehicle or purchased it used and/or sold it before August 30, 2019, you will receive a prorated payment based on the number of months you possessed it. The monthly compensation for each Class Vehicle can be found at [www.VWmpgSettlement.com](http://www.VWmpgSettlement.com). The total compensation available to the Class is approximately \$96.5 million.

### What Do I Need To Do?

- You must submit a claim to receive your payment. Go to [www.VWmpgSettlement.com](http://www.VWmpgSettlement.com) to submit a claim online. You can also download a claim form on the Settlement Website or call and request one and file by mail. The fastest option is to submit your claim online. **You can submit your claim now**, and must electronically submit or postmark it no later than 30 days after final approval. Under the current schedule, **the claim deadline is March 29, 2020**. This schedule may change, so please visit the Settlement Website regularly for updates.

### How Do I File an Online Claim?

Insert your VIN, fill out the claim form and submit required documentation.



Under the current schedule, the deadline to file your claim is **March 29, 2020**. You should submit your claim now.

***Payments will be sent to claimants after settlement approval.***

### What Are My Rights?

- You may object to or exclude yourself from the Settlement by **January 17, 2020**. If you exclude yourself, you will not receive any compensation under the Settlement. If you do not exclude yourself from the Settlement, you will not be able to sue the Defendants separately for the claims this Settlement resolves. Visit the Settlement Website for information on how to object or exclude yourself.
- The Court will hold a hearing on **February 28, 2020**, to consider whether to grant final approval to the Settlement.
- Class attorneys will request Court approval of \$13 million in attorneys' fees and costs. **Those fees and costs will be paid separately from and in addition to the cash payments available to the Class, and will not reduce Class Member recovery in any way.** You can also hire your own attorney at your own expense, but you do not have to.

Court-Approved Legal Notice

This is an Important, Court-Approved Notice  
about a Class Action Settlement



**You may be eligible for a class action settlement payment as a current or former owner or lessee of certain gasoline engine Volkswagen, Audi, Porsche, or Bentley vehicles.**

Payments for original and sole owners of the vehicles range from \$518,440 to \$2,332,800.

You are receiving this notice because you may be a current or former owner/lessee of a gasoline-powered Volkswagen, Audi, Porsche, and/or Bentley vehicle that is included in a proposed class action settlement. The Settlement resolves claims that certain vehicles sold or leased in the United States are equipped with software that may cause them to emit more carbon dioxide and obtain worse fuel economy on the road than in testing conditions. Defendants deny the claims but have decided to settle. The Court has not decided who is right. The purpose of this notice is to inform you of the proposed class action and the proposed settlement so that you may decide what to do. **A list of the vehicles (called "Class Vehicles") can be found at [www.WmmpgSettlement.com](http://www.WmmpgSettlement.com).**
